- The profit per trade every 3 hours varies from 0.3375% to 0.4875%, allowing for a daily profit of 2.7% to 3.9% if 8 trades are made per day. The company takes 0.3% of the profits for the insurance fund, leaving the user with a profit of 2.4% to 3.6% per day.




